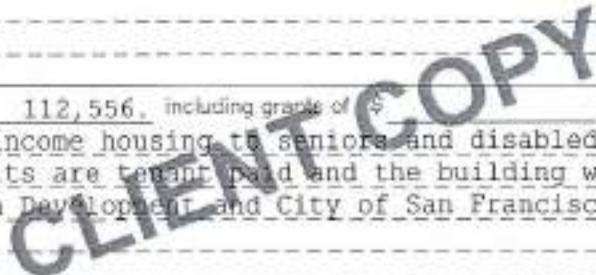

Community services were provided to 427 unduplicated clients including 1701 social services, 608 scheduled activities, 282 translations. Meals programs are in accordance with policy memorandum and direct supervision of the San Francisco Dept of Aging and Adult Services Office of Aging, Human Service Agency. RACS met and exceeded all goals in the San Francisco Meals program
